

#### NOW THEREFORE:

Considering these legal and institutional relations, the successful implementation and operation of the Railway Engineering Courses affiliated to Solapur University requires the partnership between the signatories which this MoU shall facilitate. #### ARTICLE I: BACKGROUND & PURPOSE OF THIS MoU

#### **Purpose**

The basic purpose of these skill development diploma Courses is to facilitate employment generation in the Rail & Transportation Sector. Where students are effectively trained theoretically and practically, to readily face the challenges in the Railway related sectors providing opportunities to the students to get employment in Railway and its allied sectors.

### ARTICLE II: AREAS OF COLABORATION IN THE (MoU)

MITCORER & Punyashlok Ahilyadevi Holkar Solapur University intend to impart training in Rail and its allied industries. The course is designed by MITCORER and their associates & Punyashlok Ahilyadevi Holkar Solapur University has willingly expressed its consent to start the course with below mentioned guidelines

- 1. The Course shall be of 300 Days inclusive of all Government Holidays and Weekends.
- 2. The Said course shall require Weekly 3 days & 2 Hrs each daytime period.
- 3. Min 60 Days out of total scheduled days will be theoretical training within the classrooms.
- 20 Days out of total scheduled days shall be onsite hands-on training, where students will be able to learn technical aspects of the Railway and its allied sectors.
- 5. Min.7 Days out of total scheduled days will be examinations (Oral & Written) & Results
- 6. Min.30 Days will be for internship to the candidates who have successfully passed the examinations. (they will not be paid any remuneration, however, they will be provided with an experience letter for the period of internship)

#### 1. Responsibilities & Scope of Punyashlok Ahilyadevi Holkar Solapur University

- To Provide Accessibility for the said Course
- Contacting Intimating all the Colleges & encouraging the students of those colleges to attend the said Programmed.
- Conducting Examinations and providing Mark sheets & Certificates of Solapur University for the said course.

#### 2. Responsibilities & Scope of MITCORER (Enclosed syllabus)

- MITCORER shall design the said course and execute the same.
- MITCORER shall provide basic course material, training to the staff, and some place to conduct the classes.
- MITCORER shall arrange the placement opportunities to the students who clear the examinations.
- MITCORER shall conduct examinations and results along with certificates.

### ARTICLE III: CO-ORDINATION AND NODAL OFFICER (MOU)

In Pursuit to this MoU, the Partners agree as follows:

Both Entities shall mutually decide and designate the Nodal Officer. The Nodal Officer will be responsible for fulfilling the objectives of this agreement & will also monitor all the activities mentioned in this agreement.
